- The proposal would adversely affect the amenity of neighbouring properties.
- The proposed access via Rookwood Close was inadequate.

The proposal to object for the above reasons was carried by 4 votes to 3.

Members unanimously objected to the application for the following reasons:		

Members unanimously objected to the application for the following reasons:

- The proposal was overdevelopment of the site.
- The proposed design of the houses would dominate neighbouring properties leading to a loss of privacy and light.
- The proposed houses would adversely impact on neighbouring properties.
- Members objected to the demolition in part of the stone wall to create a pedestrian access.
- Members objected to the loss of the conifer (T6) and questioned whether the site was large enough to sustain a replacement tree of a similar size.
- Members felt that the proposed pedestrian access would adversely affect the amenity of the residents of unit 1.

• Members had concerns about the effect the development would have on the existing trees on the site and on a Sycamore located adjacent to the site.

(2 letters of objection were received)

Members unanimously requested that the Deputy Clerk contact the Tree Office at EDDC to request that a TPO be made in respect of trees labelled T5 and T6 by the applicant, the copper beech on the site and the sycamore adjacent to the site.
