20/0003/FUL	Mr. Julian Gigg	Land South of Littletown Villas, Manor Crescent, Honiton. Construction of timber shed.

Members **OBJECT** to the proposed development for the following reasons:

- The proposal was for a change of use of the land which was not justified. As evidenced by photographs provided as part of a previous application, the land was previously used as a playpark. The applicant has described the land as currently being used as an allotment.
- As the Allotment Authority for Honiton, the proposal to develop allotment land was contrary to planning policy RC3 of the East Devon Local Plan 2013 -2031.
- The proposal was overdevelopment of the site.
- The size of the proposed building was inappropriate for the site.
- Members queried the need for and the future purpose of the proposed building and

were of the view that insufficient information regarding this had been provided by the applicant.

(6 votes for; 1 abstention).

3 letters of objection were received.

2 members of the public spoke objecting to the application.

Members unanimously **OBJECT** to the felling of **H3** which provides amenity value to the site and which should be protected as it provides a good barrier between the building merchants and the new houses proposed.
