## Local Development Framework—Thank you

Honiton Town Council would like to thank all residents who came to the public meeting on 1st November, talked to Councillors outside St Paul's on 30th October and 9th November, or completed the questionnaire printed in the local press. This enabled the Council to properly reflect the views of residents when submitting its response to the East Devon District Council consultation on the Local Development Framework Preferred Options document which sets out plans for the area and the town up until 2026.

The main concern expressed by the Town Council was that no further development should take place until sufficient infrastructure and services are put in place as it feels that this opportunity was missed when the bulk of Honiton's expansion took place. In addition the Council flagged up issues over housing, employment, roads and transport, cultural and sporting facilities, health and wellbeing, and green spaces.

With regard to housing the Town Council agreed that there should be no significant development outside the current boundaries and priority should be given to one and two-bedroom developments which would be suitable for both young and older people. In addition it said it would like to see higher grade or non-retail employment opportunities in the town.

# IMPORTANT DISTRICT & TOWN COUNCIL ELECTIONS 2011

Local elections are to be held on Thursday 5th May 2011 and it is important that we encourage as many of the electorate as possible to participate, including those who are eligible for their "first vote" and those who are new to the area and will need to register themselves at East Devon District Council to be included on the electoral roll [www.easdevon.gov.uk/elections](http://www.easdevon.gov.uk/elections) (01404 517543). For further information look at [www.aboutmyvote.co.uk](http://www.aboutmyvote.co.uk) which has further details you may need to know.

The reality is that if you vote - you decide what gets done. By selectively choosing who will take decisions on your behalf it is important that the opinions of who you vote for reflect your personal views. From the right to make representations on planning applications, to the state of footpaths and street lighting, town councils have a wide range of ever increasing responsibilities and duties. These decisions affect your every day life. Find out more about your local council and help them to understand and represent your community needs.

Town and parish councils are the closest tier of local government to the man and woman in the street. Town councils represent the concerns and aspirations of a genuine local community; they live within it. They are not a voluntary organisation, not a charity nor anything to do with the Church.

More and more services are being delegated to town and parish councils from their District councils including leisure facilities, support for museums, Tourist Information Centres, town centre closed-circuit television systems, as well as services such as providing halls and allotments.

Councils can only act within the law by exercising their powers and functions which have been conferred on them by Acts of Parliament (Statutes). These Statutes continue to change and proposals announced by the new coalition government especially in relation to "Decentralisation and Localism" gives a clear indication about the Government's plans to reinvigorate local politics by giving more power to Councils and communities. Already Local Council responsibilities are many and varied, including the purchase of land and buildings, providing and maintaining local life.

You may be thinking of standing as a Councillor; to get a chance to make a difference, to shape the future of the area you live in and meet some interesting colleagues and learn a bit along the way. Why not give it a try?

Surveys have shown that many people wish to become involved in local governance, but do not know how to begin. Whilst a relatively easy process it is strict and if not followed exactly will result in disappointment and rejection for the wrong reasons. Councillors are elected by the public and serve four year terms in office; these were unpaid positions until 2004 when allowance schemes were introduced to encourage more people to stand for election. Allowances are at the discretion of the individual councils.

**Eligibility:** You need to be:

- Over 18 years of age,
- A British citizen, a qualifying Commonwealth citizen, or a citizen of any other member state of the European Union.
- On the Electoral Register for the council area for which you wish to stand.
- A local government elector of the parish; or a person who during the whole of the twelve months before nomination as a candidate occupied land OR other premises as owner or tenant in the parish, OR has, during the same period, resided in that area or within three miles thereof; OR has during the same period had a principal place of work in that area.

## CENSUS 2011 - 27th March 2011

The 2011 Census is a major public event and will be the biggest in the UK this side of the 2012 Olympics. Many of the services we take for granted every day depend on it. That's why we all have to play our part in making it successful.

Government, local authorities, healthcare, education, academics, commercial business, professional organisations need to know and understand the make-up of the population so that they can plan services that reflect the needs of local communities and the nation as a whole. For more than two hundred years, the benchmark for this information has come from the census.

The design for the 2011 Census builds upon lessons learned from the past, steadily helping to understand more about what we need to do to get everyone interested and involved - and to help make sure everyone's needs are accounted for.- and we mean everyone. Census statistics are used to help plan and deliver the services we all need. Whoever we are. Wherever we live.

### Isn't the census simply a matter of filling in a questionnaire?

Well, that's exactly how the Government want you to feel about it. Something you'll just do as a matter of course.

Behind that very simple idea, is a vast and complex operation, underlined by many procedures. It's a very big thing - plans started in 2001, directly after the last one!
