21/17/SC Budget setting 2022-2023

Members considered the <u>budget headings</u> and made the following recommendations to Finance and Policy Committee on 29th November 2021 in respect of the budget and precept setting:

Cllr McCollum joined the meeting 18:14pm

Confirmed that any salary underspend from 2021/22 could be used to establish a social media budget, with Full Council approval.

Proposed £2,500 Tourism Budget.

Noted that electric vehicle charging points could be self-funding and therefore not needed as a budget heading.

Noted that the Climate Change WG has asked for a visit to and research of Honiton to assess carbon footprint and propose actions.

Proposed £10,000 Climate Change budget.

Proposed £3,000 Health & Wellbeing budget.

Proposed £15,000 Youth Sports (to incorporate £12k budget already included).

Proposed £5,000 added to the Neighbourhood Plan Earmarked Reserve (EMR) of £20k.

Proposed £0k for Fair Trade town.

Proposed £1,000 budget heading for each Working Group.

It was suggested that the budget heading relating to the HCC be revised and that the lease to HCC enables HCC to apply for funds from HTC and not to include an EMR.

Proposed £3,000 for Councillors' Strategy.

Proposed £20,000 for Public Engagement, for example noticeboards, surgeries, communications/social media and Neighbourhood Planning. Committee noted that there will be staffing implications of the above.

Members RESOLVED unanimously to recommend to Finance and Policy Committee on 29th November 2021 in respect of the budget and precept setting.
