If members of the public make a representation to the meeting or simply attend, they will be deemed to have consented to being audio recorded. Voting will also take place by a show of hands and the Clerk will indicate that the votes have been counted.

1. Apologies for Absence

To **RECEIVE** apologies and **RESOLVE** to approve any reasons for absence.

2. Declarations of Interests

To **RECEIVE** any declarations of interest.

Members are reminded that if they have a Disclosable Pecuniary Interest (DPI) (on their register of interest or otherwise) relating to any item on the agenda they are prevented from participating in any discussion or voting on that matter at the meeting as to do so would amount to a criminal offence. Similarly, if you are or become aware of a DPI in a matter under consideration at this meeting which is not on your register of interests or is in the process of being added to your register you must disclose such interest at this meeting, leave and not Vote on the item and register the DPI within 28 days. Similarly, other Personal Interests should be declared at this meeting.

3. Dispensations

To **NOTE** applications for and grant of dispensations made by the Town Clerk in relation to the business of this meeting.

4. Public Question Time for items on the agenda

Questions relating to items on the agenda may be asked at the meeting, at the discretion of the Mayor or meeting chairman. No more than 3 minutes will be allowed for any person speaking and normally up to a total of 15 minutes will be permitted. The council may respond verbally at the meeting or subsequently in writing. Members of the public will be allowed to speak at the beginning of the meeting in the usual way. To ensure the smooth running of the meeting, members of the public should provide their questions in writing prior to midday on the day of the meeting. Questions received after midday will not be tabled at the meeting.

5. Reports from District and County Councillors

Council is asked to **NOTE** (and may ask questions on) the report/s from District and County Councillors.

6. Reports from Honiton Town Council Members with Special Responsibilities and/or on Outside Bodies

Council is asked to **NOTE** any report/s from Town Councillors with Special Responsibilities and/or on Outside Bodies.

7. Reports and Recommendations from Working Groups and Committees

Council is asked to **NOTE** any reports from Town Councillors on Working Group and to **RESOLVE** to approve any Recommendations from Working Groups and Committees, of which Councillors have previously been notified, eg:

- a. Call for Councillor volunteers for Armed Forces Day; and
- b. Installation or fencing and barriers at Dowell St corner wall.

Council is asked to **NOTE** two Councillors' resignations.

13. Council Advocate (OPCC and Devon & Cornwall Police)

Council is asked to **RESOLVE** to:

- (a) approve that Council appoints a Council Advocate;
- (b) select a Councillor to be the Council Advocate; and
- (c) (if possible) select a Councillor to be single point of contact with the Police. Council is asked to **RESOLVE** to select a Councillor to attend the Honiton Community Safety Group.

14. Charter Day

Council is asked to **NOTE** that the Planning Group will not organise Charter Day after the 2025 event and **RESOLVE** to prepare an options appraisal.

15. Annual Governance & Accountability Report (AGAR) 2024/25

Council is asked to consider, complete and to approve the AGAR 2024/25, Part 3 (to be signed at a later date by the Chairman and Clerk and provided to the External Auditor and Published by the Town Council by 1 July 2025), <u>public notice</u>, <u>internal audit report</u>, <u>variances</u> and <u>variances to other payments</u>, <u>reconciliation</u>, <u>earmarked reserves</u>, <u>differences (box 7 and 8)</u> and <u>evidence of GPC (certificate</u> and <u>Councillors</u>).

- a. RESOLVES to approve Section 1: Annual Governance Statement 2024/25; and
- b. **RESOLVES** to approve Section 2: Accounting Statement 2024/25.

16. Earmarked Reserves (EMR)

Council is asked to **RESOLVE** to approve the list of Earmarked Reserves (Recommended by Finance & Policy Committee May 2025).

17. Accounts

Council is asked to **RESOLVE** to approve the schedule of accounts for May 2025 payments.

18. Exempt Business

Council is asked to **RESOLVE** that under section 1, Paragraph 2 of The Public Bodies (Admission to Meetings) Act 1960, the press and public be excluded from the meeting for items of business in view of the likely disclosure of confidential matters about information relating to an individual, and information relating to the financial or business affairs of any particular person, within the meaning of paragraph 1 and 8 of schedule 12A to the Local Government Act 1972 (see section1 and part 1 of schedule 1 to the Local Government (Access to Information) Act 1985, as amended by the Local Government (Access to Information) (Variation) Order 2006.

19. Underwriting of Honiton Community Complex (HCC) Costs

Council to **RECEIVE** an update from Councillors on Review Meeting and Chairman of the Review Meeting or HTC's nominated HCC Director and is asked to **RESOLVE** to approve financial support of HCC's net operating loss February and March 2025.

20. Honiton Community Complex (HCC) Charity Members Meeting

Council is asked to **NOTE** progress on securing a lease of the Beehive including HCC Charity Members' meeting and to **RESOLVE** (if considered necessary) to complete the Contingency Plan B, ready for implementation from July 2025.

21. To close the meeting

Reminder for Members

- You must declare the nature of any disclosable pecuniary interests. (Under the Localism Act 2011, this means the interests of your spouse, or civil partner, a person with whom you are living with as husband and wife or a person with whom you are living as if you are civil partners). You must also disclose any personal interest.
- You must disclose your interest in an item whenever it becomes apparent that you have an interest in the business being considered.
- Make sure you say what your interest is as this has to be included in the minutes.
 (For example, 'I have a disclosable pecuniary interest because this planning application is made by my husband's employer'.)
- If your interest is a disclosable pecuniary interest you cannot participate in the discussion, cannot vote, and must leave the room unless you have obtained a dispensation from the Clerk or Deputy Clerk.
- Confidential information can be viewed at the Town Council Office during public opening hours of 10am – 1pm or by pre-arranged appointment for outside office hours.

PLEASE NOTE THAT MEMBERS OF THE PUBLIC ARE WELCOME TO ATTEND THIS MEETING AS OBSERVERS

Under the Openness of Local Government Bodies Regulations 2014, any members of the public are now allowed to take photographs, film and audio record the proceedings and report on all public meetings (including on social media). No prior notification is needed but it would be helpful to let the office know of any plans to film or record so that any necessary arrangements can be made to provide reasonable facilities to report on meetings. This permission does not extend to private meetings or parts of meetings which are not open to the public. All recording and photography equipment should be taken away if a public meeting moves into a session which is not open to the public.

If you are recording the meeting, you are asked to act in a reasonable manner and not disrupt the conduct of meetings for example by using intrusive lighting, flash photography or asking people to repeat statements for the benefit of the recording. You may not make an oral commentary during the meeting. The Chairman has the power to control public recording and/or reporting so it does not disrupt the meeting.

Members of the public exercising their right to speak during Public Question Time may be recorded.
