Following Committee on 12th March 2025, Committee **NOTED** progress with actions arising from Annual Council May 2025: Terms of Reference for all Committees now includes Delegation for quick Decisions; Delegation of implementation of PIPs approved by Full Council; that all PIPs need a Councillor Lead; Project progress is reported to relevant Committees; and that changes to PIPs need approval of Full Council.

25/28/SC Devon Local Government Reorganisation (LGR)

Committee is asked to **NOTED** the Government's English Devolution White Paper (December 2024); East Devon District Council's and Devon County Council's responses. Full Council 14 April 25 Delegated to Strategy Committee **CONSIDERED** Cllr R Sexton's (with Clerk's comments) draft paper (Planning for Unitary Authorities) and responses to DALC, DCC and EDDC). DALC #24 2025 E-bulletin. Draft paper to be completed by Cllr R Sexton and Town Clerk and then presented to Full Council for approval and then to EDDC and DALC. Cllrs provided comments. HTC response to DALC to be sent to DALC. Once approved by Full Council the paper can cascade into Services/Assets that the Town Council wants to provide, to be able to achieve the priorities: economy and tourism. Committee highlighted that Precept will need to increase if HTC plans to transfer Services/Assets. HTC needs to present the case for transfer of Honiton's Services/Assets to EDDC. Information is needed in particular on education.
