The TC summarised the paper including possible transfer of net income generating and net cost services/assets. Committee discussed impact on Council budget 26/27 and also impact on service levels if the Council does not transfer. Assets should be in good condition upon transfer. HR and Legal services may be needed 26/27.

Committee Noted suggested time for application for Silver level award in January 2026. Committee discussed the lifespan of the existing Foundation level award. Council representation on Outside Bodies demonstrates 2-way communication. Adding Cllr biographies is straightforward; Cllr RS will provide an example. Action Planning should be derived from planned "away day". Demonstrating 2-way communication is more difficult and 12 months may be needed. TC to email all Cllrs asking for biographies and to highlight importance of learning.
