

ROAD TRAFFIC REGULATION ACT 1984 SECTION 14
THE COUNTY OF DEVON (TEMPORARY RESTRICTION) (HONITON AND DISTRICT
AGRICULTURAL SHOW, WESTON) NOTICE 2025
TEMPORARY TRAFFIC RESTRICTIONS

DEVON COUNTY COUNCIL hereby give **NOTICE** that:

On **THURSDAY 7 AUGUST 2025**
for a maximum of 21 days

Anticipated Finish **THURSDAY 7 AUGUST 2025**

TEMPORARY ONE WAY SYSTEM

Between the hours of **07:00** and **13:00**.

No person shall cause or permit any vehicle to proceed in a SOUTH WESTERLY direction on the sections of Affected Roads.

Roads affected -**ROAD THROUGH FENNY BRIDGES FROM A30 EXIT SLIP TO NAGS HEAD ROAD, NAGS HEAD ROAD.**

The alternative, signed, route for vehicles will be via - ROAD FROM WESTON CROSS TO KINGS ARMS FARM, HAYNE LANE, DEVONSHIRE ROAD, HEATHPARK WAY, EXETER ROAD, A30.

Between the hours of **13:00** and **19:00**

No person shall cause or permit any vehicle to proceed in a NORTH EASTERLY direction on the sections of Affected Roads.

Roads affected -**NAGS HEAD ROAD.**

The alternative, signed, route for vehicles will be via - A30, EXETER ROAD, HEATHPARK WAY, DEVONSHIRE ROAD, HAYNE LANE, ROAD FROM WESTON CROSS TO KINGS ARMS FARM A30.

PROHIBITION OF PARKING

Between the hours of **07:00** and **19:00**

No person shall cause or permit any vehicle to park or wait on the sections of Affected Roads.

Roads affected -**NAGS HEAD ROAD, FROM A POINT 115M SOUTH/SOUTH WEST OF KINGS ARMS FARM TO A POINT 150M NORTH EAST OF MEADOW VIEW (LAY-BY).**

PROHIBITION OF STOPPING

Between the hours of **07:00** and **19:00**

No person shall except upon the direction or with permission of a Police Officer in uniform cause or permit any vehicle to stop on the sections of Affected Roads.

Roads affected - **DEVONSHIRE ROAD, FROM ITS JUNCTION WITH HAYNE LANE TO ITS JUNCTION WITH HEATHPARK WAY.**
